### Gender Equity & Sensitization

Our institution is a Girls' College. The institution aims to groom students to be self-reliant, specialists in their chosen discipline, continuous learners, effective communicators, respectful to different cultures, socially responsible, aware of their social and civic responsibilities, sensitive to gender issues with zero tolerance towards sexual harassment, women safety and security, and environmental consciousness. **Women Cell**

- The name of the Complainant will be kept CONFIDENTIAL.
- Each such incident (of harassment) results in violation of the fundamental rights of "gender equality" and the rights to life and liberty". It is a clear violation of the rights under Articles 14, 15 and 21 of the Constitution.
- Such violations, therefore, attract remedy under Article 32 for the enforcement of these fundamental rights of women.

- To ensure that victims and the witnesses are not victimised or discriminated because of their complaint.
